

## **Affidavit of Support for International Students at Temple University**

### **Instructions for Completing Affidavit of Support:**

1. This form is to be completed by the person(s) who will be providing financial or other support to a student at Temple University. If there is more than one sponsor, each sponsor must complete an Affidavit of Support.
2. **The form must be thoroughly completed and in English.**
3. The sponsor(s) must complete **ALL** sections on the form. **Any section left unanswered will result in delays in processing the I-20 or DS-2019**
4. All documents should be uploaded by the student using the account at noncredit.temple.edu. Additional information or original documents may be required in order to verify a student or sponsor's ability to fund studies. All original forms and documents will be required by the student at the time of visa application/interview.
5. Sponsors in the United States must have this form notarized. If a sponsor is from a country outside the U.S., the document does not need to be signed by a notary public, but we recommend an official bank stamp where available.
6. Sponsors residing in the U.S. who plan on providing free room and board must also submit the supplemental Affidavit of Support for Providing Free Room and Board. The sponsor providing free room and board does not have to be the same person providing financial support. The student may have more than one sponsor.
7. **A bank statement which is less than 6 months old must be uploaded with the affidavit of support showing the present balance. The bank statement should demonstrate the ability to provide the financial support indicated below.**

To the Student:

Please navigate to [Tuition Rates / Tuition Calculator | Bursar's Office \(temple.edu\)](#) and obtain the tuition to be charged for your college/school annually. The annual rate consists of the fall and spring semester. There are additional charges associated with summer registration and insert that amount in the table below.

Then enter the estimated living expenses, dependent expenses, if applicable, and “other” expenses. Other expenses include estimated expenses for health insurance, books, entertainment, etc.

1. Sponsors should be aware that students are only permitted to work in limited circumstances with prior approval from the Designated School Official. For the first year in F-1 status, **students are ONLY eligible to work on campus for 20 or fewer hours per week and work is not guaranteed.** Students will not be able to support themselves through employment.
